This Week's Interesting Plays



Beyond R's restraining line, this free kick had both **R players** and **K players** touching the ball before it went OOB at the R-30



Valid, **Invalid** or **Illegal Fair** Catch Signal



To protect the QB **A16**, teammate **A5** blocks rushing **B10**.



The accepted 15 yard penalty from the **previous spot** will result in a 2nd and 28 @ B-31.



Plays 1-3: "You Make the Call"

Field goals during regulation time?

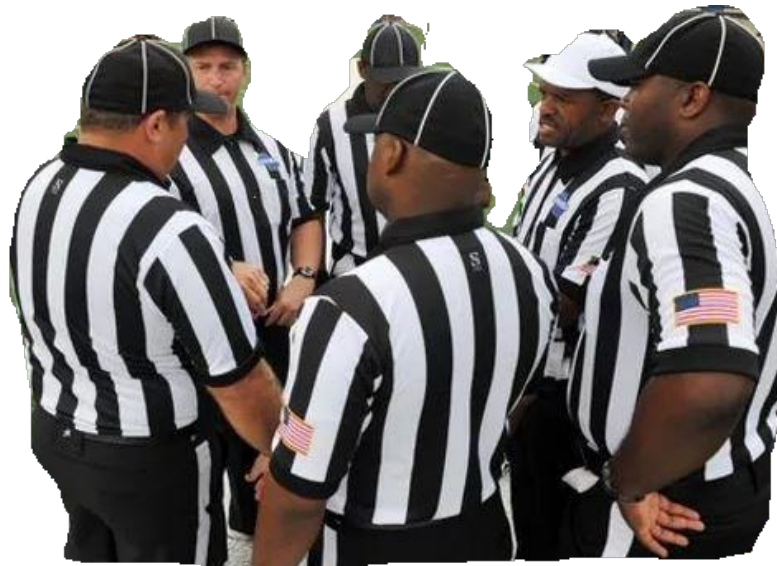


4th and 10 @ B-15. A12's fourth down field goal attempt **hits the ground** **BEYOND** the line of scrimmage and **bounces back behind** the line of scrimmage. A12 scoops up the ball and runs to the B-8 short of the line to gain.

Quarter 3



Decide the correct answer?
(Think, Turn & Talk for 2 minutes)



ANSWER

Team A did **NOT** make the line to gain.

Team B's ball -1st and 10 @ their 8 yard line.

4th and 10 @ B-15. A12's fourth down **field goal attempt** is **touched by R10** **BEYOND** the line of scrimmage and **bounces back behind** the line of scrimmage. A12 scoops up the ball and runs to the A-8 short of the line to gain.



Decide the correct answer?

ANSWER

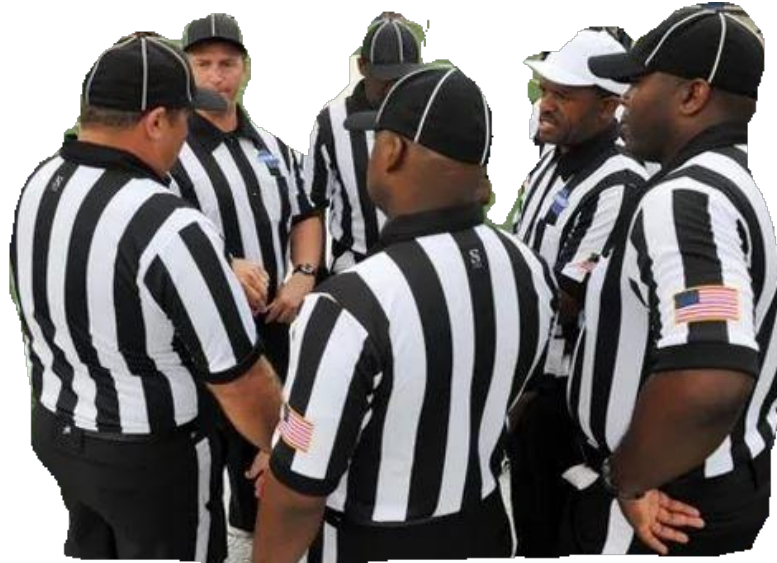
Since **Team B touched** the ball **beyond** the line of scrimmage and Team A recovered the ball, the continuity of downs is broken.

Team A's ball -1st and 10 @ B-8.

Team A's **1-point try** attempt is **blocked by R10** and recovered by A12 who scoops the ball up and runs across the goal line.



Decide the correct answer?

ANSWER

The **ball is dead** when it is
"apparent the kick will not score".

The **try is over**.

Plays 4-5: "You Make the Call"

Plays during OVER TIME?



MIAA Modifications

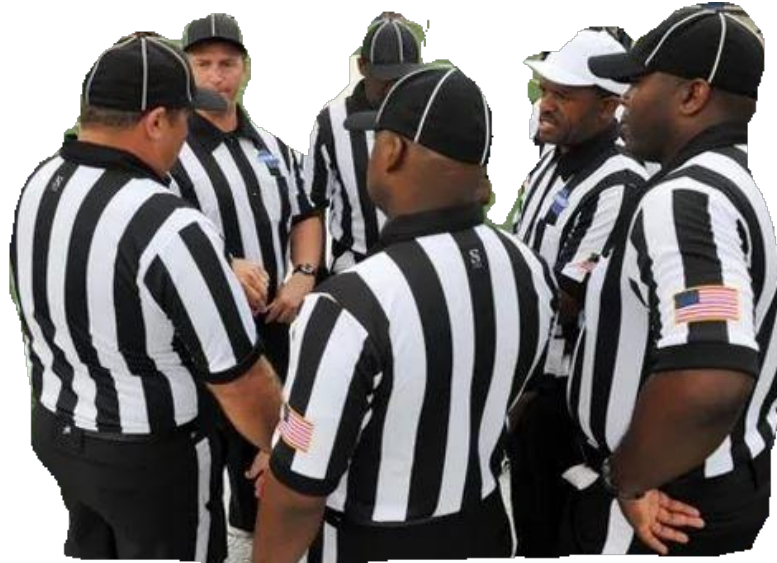


2nd and goal @ B-4 in **OVERTIME** in Massachusetts. A12's forward pass is **intercepted** by B10 who leaves the end zone and runs to B-8 and **fumbles**. A12 **recovers** the fumble at B-10.

Overtime



Decide the correct answer?
(Think, Turn & Talk for 2 minutes)



ANSWER

Team A's series of downs
is over once Team B
intercepted the pass.

4th and goal @ B-13 in **OVERTIME** in Massachusetts. A12's **Field Goal Attempt** is **touched by B10** at the B-5 and then **recovered by A12** at the B-4.



Decide the correct answer?

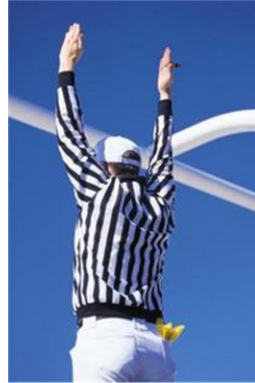
ANSWER

The **ball is dead** when A12 gains possession. It will be **Team A's ball 1st and goal @ B-8.**

The offensive team recovered a FG attempt after it had been touched first by the opponent beyond the neutral zone. Team B never gained possession, therefore they didn't stop Team A's drive in four downs. **It is rare**, but **Team A is awarded a new series!**
